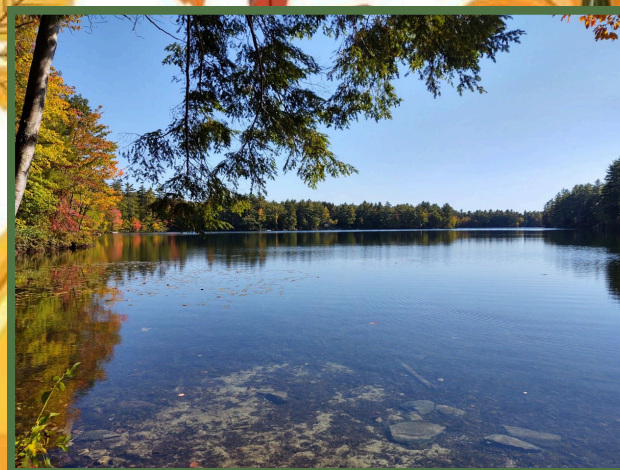
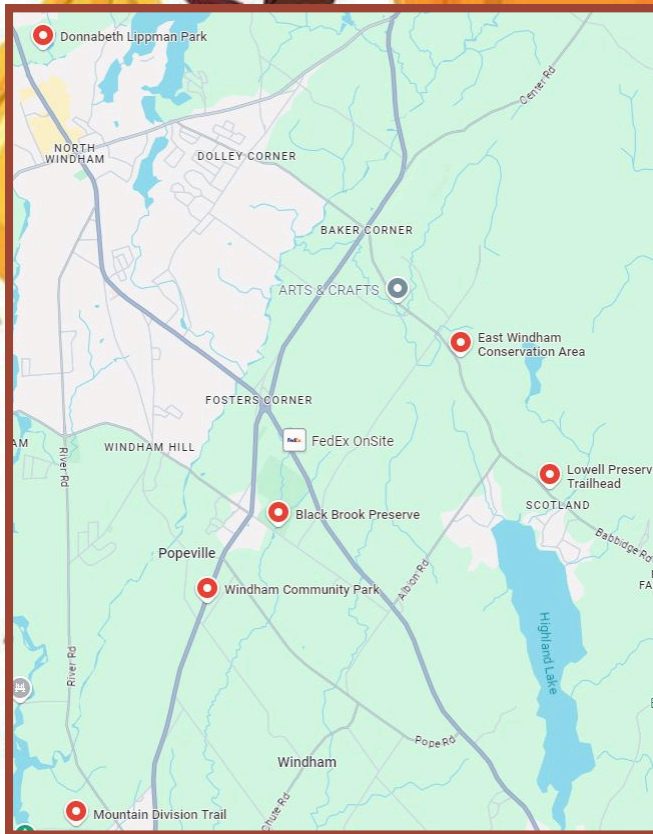

Take this trails passport on your outings, and stamp the correct square on your passport; if you cannot locate the stamp you may draw the image of the stamp displayed on the sign at the passport station.

Every completed passport will earn a prize when submitted at the Parks and Recreation office in Windham Town Hall.

ABOUT THE TRAILS

Donnabeth Lippman Park – Popular 123-acre park located in the North Windham business district behind Sherwin Williams at 18 Chaffin Pond Rd.

Lowell Preserve – 308-acre wooded preserve located at 47 Falmouth Road in East Windham.

Mountain Division Trail – Paved rail with trail for biking and walking that connects Windham, Gorham, & Standish. Parking available off Gambo Road.

Windham Community Park – Located next to the Windham Public Safety building, 373 Gray Rd in Windham. The park includes a skate park, basketball courts, volleyball courts and a picnic pavilion!

East Windham Conservation Area – The newest destination in Windham, 100 acre preserve is located at 189 Falmouth Road in East Windham.

Black Brook Preserve – 105-acre preserve on Windham Center Road, owned by the Presumpscot Regional Land Trust, parking on Windham Center Rd.
